SUBJECT: HB 2086 Annual Criminal Justice Policy Impact Statement

House Bill 2086, Eighty-first Legislature, Regular Session, 2009, directed the Legislative Budget Board to prepare an annual criminal justice policy impact statement related to the bill's provisions. The bill amended various statutes. The requirements of the annual criminal justice policy impact statement primarily relate to changes in the Penal Code.

The bill expands the offenses which may be considered as Engaging in Organized Criminal Activity and enhances penalties for the offense of Criminal Solicitation of a Minor in certain instances. The bill also creates and defines the offense of Directing Activities of Certain Criminal Street Gangs. In addition to these Penal Code amendments, the bill allows certain civil actions to be taken against criminal street gangs.

Based on fiscal year 2019 arrest and incarceration data provided by the Texas Department of Criminal Justice and the Department of Public Safety, the probable impact on criminal justice populations as a result of implementing the bill cannot be determined because the data or information providing the level of detail necessary to analyze the bill's amendments to certain Penal Code statutes are not available at the statewide level. This detail includes the location of the offenses (e.g., within 1,000 feet of a playground, shopping mall, etc.). This missing detail prevents some of the analysis of persons affected by this bill.

In fiscal year 2019, approximately 6,839 individuals were arrested for escape, permitting or facilitating escape, introducing or providing implements for escape, or prohibited substances and items in a correctional facility (33.4% White; 28.9% Black; 36.6% Hispanic; 1.1% Other). In fiscal year 2019, a total of 1,151 individuals were admitted to prison (38.1% White; 31.9% Black; 29.6% Hispanic; 0.4% Other) and 265 were admitted to state jail (35.1% White; 42.6% Black; 21.9% Hispanic; 0.4% Other). The number admitted to prison and into state jail are higher than in past years because this year LBB staff received a more comprehensive dataset which included all of the offenses belonging to those received into custody. In past years data received included only the offense of record, the most serious offense. Due to the data limitations discussed above, it is unknown whether anyone engaging in organized criminal activity would appear to have committed the offense of escape, permitting or facilitating escape, implements for escape, or prohibited substances and items in correctional facility attributable to the aforementioned arrests and/or incarcerations. In fiscal year 2019, fewer than ten individuals were arrested and fewer than ten individuals were admitted to prison for directing activities of certain criminal street gangs as defined by the provisions of the bill. Data regarding civil action damages and asset forfeiture or seizure are not available to the LBB staff.

Although data limitations prevent a complete assessment as required by the bill for the annual criminal justice policy impact statement, no significant fiscal impact or significant impact on the programs and workload of state corrections agencies or on the demand for resources and services of those agencies based on the information available is anticipated.
